Applicants that meet these criteria are not automatically approved, and we will consider any additional criteria and information that we deem relevant in connection with each application. Applicants can appeal a decision with respect to their application by submitting their appeal to the ACHKC’s General Committee at [gm@achkc.org](mailto:gm@achkc.org). Appeals must be submitted in writing within 14 days of the decision notification and should include the decision being appealed, grounds for the appeal and any supporting documentation. All decisions of the ACHKC’s General Committee with respect to an appeal are final.
